Highlights

Afghanistan has the world's largest and oldest demining program. It remains one of the states with the highest level of contamination from landmines and explosive remnants of war. It has the highest number of casualties caused by landmines, explosive remnants of war and improvised explosive devices over the 1999-2008 period, with 12,069 casualties recorded.

In Cambodia, at least 7,300 casualties caused by mines, explosive remnants of war and improvised explosive devices were recorded between 1999 and 2008, for a total of more than 60,000 casualties since 1979.

Myanmar/Burma is one of only two governments that have used landmines in the past years, the other one being Russia.

China, a state not party to the Mine Ban Treaty, has the world's largest stockpiles, with an estimated 110 million stockpiled antipersonnel landmines.

Prasanna Rajiv Kuruppu - A Sri Lankan landmine survivor, Kuruppu has led efforts to establish rights and social services for combat casualties and persons with disabilities in the wake of civil war in Sri Lanka. He was the first individual award recipient of the *Stavros S. Niarchos Foundation Prize for Survivorship*, awarded to a survivor who has contributed to reconstruction and reconciliation. *Language: English*
